1 - ACCEPTANCE OF RISKS

I am participating on my own initiative in a speed driving activity, as a driver or rider or passenger, on a closed track. I also declare that I am the holder of equipment that complies with the technical and safety regulations of the FFSA and FFM in force on the day of my participation.

I accept that I will drive or ride or be a passenger in or on a motor vehicle on the Circuit of Nevers Magny-Cours, with full knowledge of the facts. I am fully aware of the dangerous nature of track driving, whether as a driver or a rider or a passenger. More generally, I declare that I am not permanently or temporarily incapacitated for driving on the circuit,

I also declare that I am in good health, that I am in full possession of my physical and mental faculties, and that I am not under the effect of any medication or other treatment likely to alter my faculties during my presence at and on the circuit. I also declare that I hold a current valid third-party liability insurance policy.

2 - WAIVER OF ALL CLAIMS

As a driver, a rider or a passenger, I hereby release the SAEMS of the CIRCUIT OF NEVERS MAGNY-COURS and the ORGANIZER, as well as the insurers of all the aforementioned natural and legal persons, from all liability in the event that I cause, through my behaviour, voluntarily or involuntarily, directly or indirectly, any damage whatsoever to a third party, a user, an employee of the Circuit, or to myself during my presence at and on the Circuit, including the Grand Prix and Club tracks and the paddocks.

3 - INTERNAL RULES AND REGULATIONS

I also declare that I have read and understood the Internal Regulations for Tracks & Areas of the Circuit of Nevers Magny-Cours, which apply, among other things, to driving or riding a motor vehicle on the track, and I undertake to comply with these provisions in all respects. More generally, I undertake to comply with all safety regulations applicable to driving on closed tracks.

4 - DAMAGE & REPAIR OF CNECV HOMOLOGATION

In the event of an incident or accident causing damage to the infrastructures of the Circuit of Nevers Magny-Cours, I undertake to pay any invoice presented to me immediately, while I am present at the Circuit, for damage I may have caused to the infrastructures and movable equipment used by the SAEMS of the CIRCUIT of NEVERS MAGNY-COURS as part of the CNECV homologation.
