Declare the following:

1- INSURANCE

I certify that I hold a valid third-party liability insurance policy and a professional insurance policy specifying "Motor Sport Circuit Photographer/Journalist Activity" including the paddocks, the track and the pitlane,
In the event of access to the safety tracks, these must be specifically indicated on the professional insurance policy.

2- DRONES

The procedure for drone flights over the Circuit of Nevers Magny-Cours is regulated as follows:
- Declaration of the flight on AlphaTango, as the Circuit of Nevers Magny-Cours is located on an air corridor close to the Avord air base,
- The drone must be in an open category with a class designation (CO/, C1, C2, C3, C4),
- It must be authorised by the Organiser.

It is forbidden to fly over the track and public/spectator areas. If necessary, and in agreement with the Circuit of Nevers Magny-Cours, time slots will be set up and adapted as required.

3- WAIVER OF ALL CLAIMS

As a driver, a rider or a passenger, I hereby release the SAEMS of the Circuit of Nevers Magny-Cours and the Organiser, as well as the insurers of all the aforementioned natural and legal persons, from all liability in the event that I cause, through my behaviour, voluntarily or involuntarily, directly or indirectly, any damage whatsoever to a third party, a customer, an employee of the Circuit, or to myself during my presence at and on the Circuit, including the Grand Prix and Club tracks and the paddocks.

4- INTERNAL RULES AND REGULATIONS

I also declare that I have read and understood the Internal Regulations for Tracks and Areas, the Media Plan and the Red Zones of the Circuit of Nevers Magny-Cours and undertake to comply with these provisions in all respects. In addition, I undertake to comply with all safety instructions in use.

5- OTHER CONDITIONS

I also declare that:

- I am not under the influence of any medication or other treatment likely to impair my faculties during my presence on the Circuit,
- I am in full possession of my physical and mental faculties,
- I have a current and up to date public liability insurance policy, covering activities related to motor sport on the Circuit of Nevers Magny-Cours.
- I have a valid current professional insurance policy;
- I hold a professional photographer and/or press card or employer's certificate;
- if I wish to access the safety tracks, I undertake on arrival at the Circuit of Nevers Magny-Cours to complete a Waiver Form with Track Services and to indicate the model of car that will be used on the safety lanes (subject to authorisation by the organisers) and to collect my safety vest /chasuble.
- I undertake to pay the SAEMS of the CIRCUIT of NEVERS MAGNY-COURS while I am present at the Circuit, any invoice presented to me, relating to damage I may have caused to the infrastructures and movable equipment used by the SAEMS of the CIRCUIT of NEVERS MAGNY-COURS

Finally, I undertake to leave the Circuit of Nevers Magny-Cours immediately if I fail to comply with any of the conditions set out in these regulations.
