

INTERNAL REGULATIONS FOR TRACKS & AREAS- NEVERS MAGNY-COURS

These rules apply to the public visiting the CIRCUIT OF NEVERS MAGNY-COURS as well as to persons and groups authorised to occupy the premises temporarily for visits, sporting activities and events.

All persons entering the venue must comply with these Internal Regulations, as well as with the laws and regulations in force.

DEFINITIONS

Accreditation: An individual access pass to the venue, owned by the Circuit of Nevers Magny-Cours and issued to a pre-identified person assigned to an Event. Accreditation allows access to one or more defined areas. The holder of an accreditation may only access these areas if they are marked on the accreditation in the form of numbers or sets of two or three letters. Accreditation must be worn visibly by the bearer, and will be checked at venue entrances and at all zone access points within the venue. Accreditation is strictly personal and non-transferable for any reason whatsoever. Forgeries are also prohibited.

Ticket: A physical medium, whether or not associated with an entrance fee, which is necessarily extracted either from a manual source or from a computerized system, or from a dematerialized system in the event that the customer prints out his or her own paper ticket after purchasing it on the Internet.

Circuit of Nevers Magny-Cours: Private company operating the infrastructures..

Sporting or Enclosed Circuit area: All fenced areas, including the various tracks of the Circuit of Nevers Magny-Cours, controlled by the Organizer and capable of providing visibility of the track.

Exterior areas: All areas located outside the Sporting Area and given access to the public by the Organizer.

Private Event: Gathering taking place in the Enclosed Circuit Area without tickets, such as a company event, congress-seminar or track days and testing..

Manager: Any private individual or corporate entity in charge of operating the infrastructures located in the Sporting Area and the Exterior Areas of the Circuit of Nevers Magny-Cours.

General Event: A ticketed or closed event taking place in the Sporting Area and requiring administrative authorization.

Organizer: Any private individual or corporate entity responsible for organizing a sporting or non-sporting event in the Sporting Area on the tracks of the Circuit of Nevers Magny-Cours. And also any customer of the Circuit of Nevers Magny-Cours renting the Sporting Area for any reason whatsoever.

Public : Any person entering the Enclosed Circuit Area and/or the Exterior Areas.

Venue: Sporting or Enclosed Circuit Area and Exterior Areas, taken together or separately.

Spectator: Any person holding a Ticket to attend an Event.

ARTICLE 1. - GENERAL CONDITIONS OF ACCESS TO THE CIRCUIT OF NEVERS MAGNY-COURS

Access to the venue is regulated and proper attire is required on the premises. The public and all individuals in general are obliged to submit to the checks carried out at the entrances and at all points inside the venue.

The provisions of the present regulations apply to all persons, whether alone or in a group, on foot or in a vehicle within the venue. Animals are not allowed inside the Enclosed Area of the CIRCUIT OF NEVERS MAGNY-COURS. Dogs are tolerated provided they are kept on a leash by their owner. They remain the responsibility of their owner in the event of an accident caused to a third party.

Any person entering the venue accepts to be bound by the Sanitary Code of Conduct in force, including any modifications that may be made to it, and undertakes to comply with it in all respects when accessing the venue for any type of gathering and/or event.

THE CIRCUIT OF NEVERS MAGNY-COURS is open at the times displayed at the entrances, except for specific times during scheduled events, which are indicated on the access tickets. It is forbidden to enter the venue outside opening hours.

The Organizer reserves the right to deny access to the venue to any minor under the age of sixteen (16) who is not accompanied by an adult holding an access ticket.

1.1 PARTICIPANTS AND ACCOMPANYING PERSONS

For the duration of an event, access to the venue for authorized motorized land vehicles and participants and/or accompanying persons is regulated. It is authorized subject to the issue of a circulation or access permit by the Organizer or the Manager of the Sporting Area and Exterior areas.

Ticket access and/or circulation or parking permits must be prominently displayed on the vehicle or person. When no event is taking place, vehicle access is subject to a badge issued against proof of identity as a deposit, or to an access code previously issued to the event organizer.

1.2 GENERAL PUBLIC

Unless expressly authorized in writing in advance by the Management of the CIRCUIT OF NEVERS MAGNY-COURS, no means of transport is allowed on the site, with the exception of wheelchairs for the sick or disabled.

Outside Private Events and General Events, access to the CIRCUIT OF NEVERS MAGNY-COURS is authorized only in the Village and on foot, subject to justification and validation by the security guard at the main entrance.

During any event, access is subject to presentation of an access ticket and/or accreditation. Falsifying an access ticket and/or accreditation, whether by possession or transfer by any means and in any place, will result in a ban on access or expulsion, and may give rise to legal proceedings. The said title will be confiscated immediately.

It is forbidden to remain within the enclosed circuit area at night, except during events that run during the night or with the express authorization of the Manager, on threat of expulsion.

Access to the track and all areas under construction is forbidden to the general public and to any person not expressly authorized by the Organizer.

Any damage to installations or buildings will be invoiced to those responsible and, if necessary, they will be prosecuted.

ARTICLE 2. - GENERAL BEHAVIOUR ON THE SITE

In general, the general public, participants and/or accompanying persons are required to avoid causing any disturbance whatsoever to the smooth running of the Events or during their visit to the venue by their behaviour, their dress or their comments, to refrain from any act likely to threaten the safety of staff and third parties, and to comply with safety instructions.

Offenders may be expelled from the venue. In the event of a repeat offence, the Organizer or the Manager reserves the right to apply to the courts for permanent exclusion, notwithstanding any application of the provisions of article L.332-II of the French Sporting Code. Fire alarms may only be triggered if absolutely necessary. Any violation will be punished.

Inside the venue, the meeting and seminar rooms, the press and media areas, the hospitality units and public relations areas, grandstands, paddocks, track and areas reserved for officials are only accessible to persons in possession of a specific entry permit.

2.1 IN THE PADDOCKS

The French Highway Code applies in the paddocks, with the rule of 'Priority to the right'.

To protect the site, it is forbidden to:

- damage plantations, uproot and take plants, pick flowers, break or cut foliage, mutilate trees and climb them,
- damage or make a path through hedges and shrubbery,
- remove advertising supports and decorative elements,
- drill holes in the ground,
- squander water and electricity,
- paint the ground,
- light fires,
- smoke near a flammable source.,

In general, to take any action likely to cause damage.

It is forbidden to use skateboards or roller skates around the venue. Two-wheeled vehicles and any vehicle deemed dangerous to the safety of the general public are also forbidden on the site, with the exception of vehicles carrying a special permit issued by the Organizer.

In accordance with the French Highway Code, helmets and CE-certified gloves must be worn when riding authorized two-wheelers.

Helmets must be worn by children under the age of 12 riding a bicycle.

2.2 IN THE GARAGES

Garages are presumed to have been found in a good condition, and the user is obliged to leave a used garage in perfect condition.

Garages must be cleaned after use.

Any damage found in a garage will be paid for by the user on site.

It is forbidden to paint or drill holes.

Waste oil must be disposed of in the containers provided in the paddock behind the garages.

No rubbish or material may be left in the garages.

Smoking is forbidden in the garages.

It is forbidden to enter a garage used by another user without their permission.

2.3 ON THE TRACK

Access to the track, both during and outside track hours, is restricted. Children under the age of 16 are not allowed on the track, even if accompanied, unless otherwise authorized.

Access to the track is forbidden to participants and/or accompanying persons outside the Track Walk. During Track Walk events, access to the track for combustion and/or electric-powered machines is strictly forbidden.

The CIRCUIT OF NEVERS MAGNY-COURS also reminds participants that their equipment must comply with the rules in force on the day of the ride or event, as laid down by the Fédération Française de Sport Automobile (FFSA) and the Fédération Française de Motocyclisme (FFM).

It is forbidden to access the safety lanes on foot, or with a vehicle other than one belonging to the circuit.

Any access to the safety lanes with a vehicle must be authorized by the Track Manager or by Race Direction.

You must decelerate to a speed of 60 km/hour at the entrance to the pit lane. The speed in the pit lane is limited to 60 km/hour.

Each participant declares that they are fully aware of the legal and regulatory provisions in force concerning noise pollution and neighbourhood disturbance, and undertakes to comply with them, in particular the provisions of the Environment Code and the Public Health Code. These rules are those laid down by the Fédération Française de Sport Automobile (FFSA) and the Fédération Française de Motocyclisme (FFM) in force on the day of the event.

It is strictly forbidden to take a camera of any kind onto the track. It is only tolerated during coaching sessions, firmly attached to the vehicle.

In the event of an incident or an accident, if a vehicle stops anywhere other than in the pit lane, it must be removed as quickly as possible so that its presence does not pose a danger to other participants. The vehicle may be attached by the bodywork or the chassis or any secure part of the vehicle for its recovery. THE CIRCUIT OF NEVERS MAGNY-COURS cannot be held liable for any damage caused to the vehicle.

Smoking is forbidden in the pit lane.

2.4 IN RECEPTION AND HOSPITALITY AREAS

Animals are not allowed in these areas, with the exception of guide dogs accompanying the visually impaired.

It is forbidden to affix graffiti, posters, marks or dirt to walls or buildings. Any person found wilfully damaging or deteriorating any movable or immovable property on-site (tearing out seats, breaking windows, tagging, etc.) or threatening the safety of persons, particularly with the use of explosive, incendiary or pyrotechnic substances, will be immediately handed over to the police.

Any visit to the Video Control Room, even if commercialized and/or organized, is strictly forbidden.

Any person prosecuted for these acts is liable to a fine of between 3,750 euros and 75,000 euros, and to five years' imprisonment under articles 322-1 to 322-4 of the French Penal Code.

In addition to these penalties, you will be required to reimburse the costs of restoration work caused by the damage. Extract from article 322-1 of the French Penal Code: "the destruction, degradation or deterioration of property belonging to others is punishable by two years' imprisonment and a fine of 30,000 euros".

Throughout the venue it is strictly forbidden to:

Fly-post, hammer nails, drill holes, glue, staple or pin anything on windows, floors (passageways, hospitality units or reception areas), doors, walls, furniture,

It is strictly forbidden to convert the space into a dormitory, or to transport any equipment outside the reception area.

In the event of damage (**theft, breakage or loss**) to the equipment provided, the cost of replacing the equipment will be charged to the hirer according to the following scale of charges:

Badge:	Price: €100.00 ex VAT
TV:	Price: €750.00 ex VAT.

Chair:	Price: €100.00 ex VAT
Round table:	Price: €400.00 ex VAT
Catering table:	Price: €140.00 ex VAT

ARTICLE 3. - TAKING PICTURES, RECORDING, COPYING AND IMAGE RIGHTS

3.1 IMAGE RIGHTS

The General Public is hereby informed that during public events, they may be photographed and/or filmed for television, cinema and internet broadcasts. All Ticket or Accreditation holders hereby authorize the Organizer or the Manager:

- as part of their promotion/communication, to make any recording of their image and/or voice or those of minors ("Images and Voices") for whom they are responsible and/or whom they accompany (if they are not the legal representative, they guarantee that they have received authorization from the minor's legal representative to give such authorization), by any process whatsoever and on any medium whatsoever, whether such recordings are made directly by the Organizer/Manager or indirectly through a third party.
- to reproduce the recordings of the Images and Voices on any medium whatsoever.
- to broadcast, for any purpose, including commercial, recordings of the Images and Voices by any means whatsoever (television, cinema, press, internet, exhibition, etc.) on the following Organizer and/or Manager media:
 - Internet, social networks, intranet, mobile data (text, SMS, MMS, Web applications, etc.);
 - Commercial and promotional brochures, posters, merchandising products, videograms (DVD, Blu-Ray, etc.).

This authorization is granted for worldwide use for a period of 10 years.

3.2 IMAGE AND SOUND RECORDING

During Private and General Events, in order to protect image rights and intellectual and artistic property rights, it is forbidden, without the express written authorization of the Organizer and Management of the CIRCUIT OF NEVERS MAGNY-COURS, to take photographs or to make visual or sound recordings of any kind.

It is forbidden to use professional cameras and/or images of the event for commercial purposes. The public is hereby informed that they may be photographed or filmed during the event (in particular for television broadcasts).

3.3 VIDEO SURVEILLANCE - VIDEO CONTROL ROOM

The site of the CIRCUIT OF NEVERS MAGNY-COURS is equipped with a video surveillance system in compliance with the French Internal Security Code. The authorization granted by prefectural decree n°58-2022-01-05-00035 concerns the following areas:

- The main entrance,
- The Conservatoire de la Monoplace Française,
- The Club Track,
- The Grand Prix Track paddocks,
- The Grand Prix Track.

The images are recorded, except in the case of a police investigation, a preliminary investigation or a judicial inquiry. Recordings will be destroyed within a maximum of 7 days.

Within this 7-day period, any access to the images must be made by solicitor's letter addressed to :

ARTICLE 4. – LOCAL NOISE LIMITS

In order to preserve local noise limits, the noise level of vehicles using the track must comply with the regulations laid down by the FFSA and FFM.

Therefore access to the track is only authorized after signature of the contract for the use of the track, and in particular the user's undertaking to submit vehicles accessing the track to a noise test.

These tests will be carried out in accordance with the technical and safety rules laid down by the FFSA and FFM.

In the event of a vehicle's noise emissions exceeding the values set by the technical rules of the delegated sports federations, the said vehicle will be prohibited from accessing the track.

ARTICLE 5. - SAFETY

The Public must avoid any action likely to endanger the safety of staff and third parties.

Any accident or abnormal event must be reported immediately to the gatekeeper on 03 86 21 80 04.

In any situation likely to endanger the safety of persons and property on the Venue, warning measures may be taken, including closing the entries and controlling the exits.

On the Site, it is forbidden to:

- bring in, to hold or use toxic, explosive, flammable, corrosive, radioactive, water-reactive, volatile, detonating or explosive substances.
- bring in laser pointers.
- bring in weapons and ammunition of any kind, tear gas canisters, knives and sharp objects.
- bring in alcoholic beverages, illegal substances, glass or plastic bottles with corks..

The public undertakes to respect the law and regulations applicable to safety in sporting venues, and in particular the provisions of articles L332-3 and following, of the French Sporting Code, which is punished with 1 to 3 years' imprisonment and a €15,000 fine, as well as an additional venue ban, the act of attempting or introducing, the possession or use of rockets or fireworks of any kind, or the introduction of any object likely to constitute a weapon (such as sharp objects), or the throwing of a projectile presenting a danger to persons (such as a glass bottle, a can, a battery, a glass or plastic container), or disrupting the progress of an event or endangering the safety of persons or property by entering the Circuit of Nevers Magny-Cours.

If it becomes necessary to evacuate the site, the public will be led away by the personnel present. Evacuation will be coordinated by guides wearing 'Accueil et Contrôle' (Reception and Security) jackets to enable an orderly exit. Everyone must comply with the safety instructions given by the personnel in charge of these operations.

Lost and found items must be handed in at the information points (or, failing that, to a security guard). They will be kept at the disposal of their owner for fifteen calendar days at the general reception desk inside the CIRCUIT OF NEVERS MAGNY-COURS - 03 86 21 80 00. After this period, the items will be destroyed.

ARTICLE 6. - SANCTIONS

Any violation of one or any of the rules set out in these regulations may result in the seizure of the offender's access card (Ticket, Accreditation) and their immediate expulsion from the Circuit. Legal action may also be taken. Under no circumstances will tickets be refunded. These measures will be implemented exclusively by the security department of the CIRCUIT OF NEVERS MAGNY-COURS.
